We are a not-for-profit organization headquartered in Bhubaneswar under the state of Odisha, India established in 2013, making concerted efforts towards the goal of creating a world free from hunger, poverty, illiteracy and ignorance. We believe that one can spread happiness by small acts of kindness and compassion to fellow human beings. These little bits of good acts aggregate to create a world more equitable, more inclusive and freer of human sufferings aimed at creating a better world to live in. We prioritize our efforts to spread happiness and hope among the deprived and underprivileged by providing financial relief & support at the time of crisis and also provide necessary support for quality education to the needy. We are committed to break the vicious cycle of poverty by providing food to the millions of deprived children and alleviating poverty through quality education. The essence of our movement is founded on the pillars of compassion and humanitarianism. The resources garnered are used to improve access to inclusive education, gender equality, uplift the indigenous people and sustainable development of the community. The participation of local community leaders holds the key who become the change makers for sustainable development.



Our educational initiative at KISS comprises of Schools, College and University founded on the pillars of food, education and empowerment to the indigenous and impoverished children Kalinga Institute of Social Sciences (KISS) located in Bhubaneswar, Odisha, India is the largest institution of the world for the indigenous children. KISS has been working

relentlessly for the upliftment of tribals and empowering them through education. At present 30,000 indigenous children are provided with food, accommodation, healthcare absolutely free to pursue their education from Kindergarten to Post- Graduation. They are nurtured here to be the change agents and through their education and training they become India's quality human resources. Earlier the indigenous children were lured by the ultras and with a few thousand rupees their parents too used to send them to join the disruptive forces. KISS has been able to stop this social menace to a great extent. Several schemes like 'earn while you learn', jobs after completion of education, trainings for sustainable livelihood, etc. have motivated these indigenous youth not to become easy prey of the disruptive forces. Several boys and girls from KISS have represented India in various national and international sports competition(s) and brought laurels to the state and India. World class bodies like UNFPA, UNICEF, UNESCO, US Department of State, British Council, Australian Government, Bernard van Leer Foundation have been associated with the KISS. KISS is also setting up KISS sister branches in different parts of the state and of country for the underprivileged children.

### Transforming social lives of weaker sections

KISS Foundation believes in providing financial support to destitute helpless women & children for livelihood & continuing education to young children, financial aid for undergoing medical treatment, support at the time of natural calamities which ravages our state frequently, feeding the poor and



starved in multiple districts, feeding the stray animals & cattle in multiple locations are some humanitarian measures which can bring some relief and smile on the face of the distressed. The myriad initiatives and timely support provided by the platform has the potential to ameliorate and transform the social lives of the distressed for weathering the challenges of life and survive with social transformation & dignity.

### Platform for relief to the poor

KISS Foundation nurtures the vision of a world free from poverty, ignorance, illiteracy and inequality, the right to access the resources and opportunities to live a dignified living for the weaker sections irrespective of caste, creed and religion can work wonders. With this belief system, the Foundation provides a platform to all the underprivileged and destitute in utter despair and need of financial help. The financial support extended for basic living and encouraging support for pursuing education at free of cost in any of the schools promoted by KISS creates hope amidst despair.

Enriched with rich wisdom of tribal hardship, educational inequities and social isolation of the underprivileged and low-income households, the passion for a new India was nurtured with a key pillar i.e., providing education for under privileged. The dream was cherished to build a fair and equitable society. The holistic model of education embraced at KISS

empowers the indigenous children with absolutely free of cost and innovative pedagogy adopted for the learners. This sets the benchmark for quality education. This includes comprehensive academic curricula, skill training, nutrition and hygiene complementing wellbeing agenda offering multiple options for extracurricular activities including sports. Imparting education at free cost provides impetus to the disadvantaged to become self-sufficient and help in reducing the inequalities and restrains transmitting the virus of poverty to future generations.





## Promoting social equity through women empowerment

Gender inequality and discrimination against women and girls are deep rooted social ills which deprive access to women / girl child for basic resources available at cultural, social, religious and spiritual levels. KISS was established with 60% girl student strength which has earned the distinction of being the path finder to many of the social and wellbeing issues like child marriage, infant mortality, maternal mortality, domestic violence etc. The educational model adopted at KISS with skills empowerment equips the girl children with greater employability, opportunities for gainful self-employment and livelihood enhancement which are key drivers towards elimination of chronic poverty thus attaining one of prime SDG goals. Kanya Kiran the flagship initiative is actively pursued at KISS to curb violence against women and saving girl children across the state of Odisha has gained wide popularity and momentum. The unique experiment of social transformation at KISS has set a bright example of inclusive education and social development.



## How we do?

### Inspiration

Education is a key activity of the KISS Foundation India which is in prime focus since inception. Our two decades of experience in imparting comprehensive and holistic education has taught the lesson that education empowers and is the panacea to many ills. Education is a powerful tool which is instrumental to raising income levels, reduces economic inequalities, alleviates poverty, induces people to make better, healthier choices and fosters confidence and self-esteem. It is central to socio-economic progress and prosperity of the nation.



## Innovation



Education plays vital role in inclusive development of the nation, state and the individual. Everybody needs to create awareness for education for all. Education resolves problems and suffering in everyday life and plays a vital role in eradication of poverty; there is a need to educate at least one person by each individual which will make big difference. The Foundation firmly believes that given the right opportunity, tribal and aboriginal students can outperform their counterparts in the mainstream society. With the objective of inclusive education, KISS was founded which a rare combination of providing modern education while preserving the ethnicity and age-old values of tribal .

community. The unique experiment of social transformation at KISS has set a bright example of inclusive education and social development. KISS prioritizes preserving varied tribal values, cultures and languages of 62 tribes including -13- PVTGs while empowering the students through holistic approach of academia, sports, and life skills with vocational training absolutely free which provides easy affordability to the underprivileged.

### Impact

Since inception of the Foundation, total number of 23 beneficiaries have got the privilege of accessing the holistic educational model offered by KISS Bhubaneswar / other Satellite centres of KISS,



out of which 18 number of distressed children have got the opportunity for continuing education during the year under review.



# Our Journey

## Establishing KISS Foundation



Founded in 2013, as a trust by the iconic educationist, social architect and reformer and Philanthropist Dr Achyuta Samanta who confronted and struggled during the first 25 years of his life with grueling poverty and hardship made it a mission of his life to provide food to the deprived and distressed and work passionately to alleviate poverty

through quality education. The unique pedagogy includes comprehensive academic curricula, skill training, nutrition, hygiene and offers multiple options for extracurricular activities including sports. No doubt this has helped the tribal children to break free from the chain of years of impoverishment away from the modern world. In other words, a sort of social revolution has taken place.

## KISS Revolution

KISS was founded for providing education to the indigenous boys and girls, free of cost which has become one of the largest residential educational institutions with 30000 students, 20000 alumni and 10000 students at satellite centers in Odisha. It cherishes a dream of educating two million poorest children over the next decade. Over two decades of association with indigenous tribals impacted lives of more than 6 lakh individuals.



## Mega Residential Model

The Indigenous tribals covering 62 tribes in 30 districts of Odisha have the opportunity to access the facilities and educational infrastructure of the world's largest mega residential school at Bhubaneswar which has earned the distinction of zero dropout rate and safety of Naxalite intervention which is committed to preserve and disseminates diverse tribal culture, traditional

knowledge, core philosophy and wide ethnicity. KISS has also played an active role in fighting other social problems like malnutrition, child marriage, gender-based persecution, extremism, proselytization, superstition & illiteracy.



## Quality Education and Healthcare



The model envisages free education, free food, free accommodation and free health care which form the key ingredient of integration to mainstream. Empowerment through equal access to resources and opportunities for holistic education of the disadvantaged is a precursor to social equity which is espoused by KISS.

## Our Intervention during the ongoing pandemic



With the onset of Covid pandemic and imposition of severest lockdowns across the country which unleashed unprecedented difficulties to the common people resulting in loss of livelihood and employment/income of the



of the pandemic. Millions were pushed to below poverty line and myriad people were suffering from hunger. It brought immense miseries to the marginalized sections who were struggling for survival impacting their efforts to earn a living. The socio-economic impacts and health outcome were colossal which increased the marginalization of the already vulnerable population.



Deeply influenced by the plight of the vulnerable and marginalized people suffering in the pandemic, the Foundation has been a forerunner in providing relief and basic necessities to ameliorate their miseries. The holistic approach includes collaborating with State Government and local self-government institutions, utilizing our existing infrastructure for setting up quarantine facilities and dedicated Covid Hospitals, distribution of Covid appropriate hygiene products, harnessing technology and innovation for sustainable solution, and providing relief to homeless, stranded migrants, slum dwellers, daily earners, transgender, beggars, frontline workers, beggars and animals on the street who were hardest hit by the crisis are some of the measures undertaken to mitigate the suffering. Social service and uplifting the bottom households have always been our priority agenda since inception of the Foundation. However, the relief measures constituted a drop in the vast ocean. Some initiatives in a nutshell are as follows-



- Through Project Uday', a massive awareness campaign was launched on social distancing, proper use of mask, hand washing and respiratory hygiene in six aspirational districts of Odisha: Rayagada, Malkangiri, Koraput, Kandhamal, Balangir, and Gajapati. More than 500 volunteers are involved in the project covering 220 villages
- Creating awareness and dissemination of covid related information like social distancing, washing hands and respiratory hygiene were widely publicized by KISS students in their respective districts
- Textbooks, study materials and dry food packets were delivered to 30000 students at their doorsteps to 30 districts of the state to save the children from hunger and continuing education
- Provides free education at KISS to the children of the Covid deceased parents in Odisha. covering two academic years: 2020-21 and 2021-22 which was widely lauded as a noble humanitarian gesture
- As one of the large community intervention, distribution of food materials and other essentials were undertaken to over 3 lakh pandemic-hit people, mostly the disadvantaged people living in various slums, stranded migrant labourers, along with temporary shelter, and people living in containment zones
- Other prominent community outreach activities include provision of one month supply to the Tibetan population in Chandragiri and Padmasambhava Monastery in Jiranga, a Tibetan settlement area in Eastern Odisha; and adoption of two old age homes in Chandragiri. KISS supported hospital at



- KISS worked closely with American Embassy in evacuation of personnel stuck in Odisha and other adjoining areas. It also distributed large quantity of feminine hygiene products to women and girls in all the districts of Odisha
- KIIT & KISS extended helping hand to the red-light areas in Bhubaneswar providing the needy groceries and other essentials. KIIT, KISS, Sakha and



and Azim Premji Philanthropic Initiatives came together to distribute ration and essential items for the transgender community in Bhubaneswar, Rayagada and a few other districts of Odisha

- Cooked foods were delivered directly to home to the needy and disadvantaged people in 15 districts of Odisha during the lock down period
- Looking beyond the windows initiative was made to deliver cooked food to police personnel on duty, who were diligently enforcing the lockdown in Bhubaneswar, Puri and Cuttack. Sourcing and distribution of fruits, vegetables, biscuits and other food materials to animals like monkeys, cattle and dogs, in and around the campus and providing financial assistance to more than 10 'Goshalas' in Puri, Bhubaneswar and Cuttack were a novel experience.

## Some noteworthy initiatives

### Tending the Tibetan Communities & Monks in Odisha to Fight COVID-19 Crisis



KISS Foundation has taken a series of initiatives to help people of Odisha and provided support to the State Government in the battle against Coronavirus pandemic. In the latest initiative, the Foundation have extended a helping hand to the Tibetan communities in Jiranga and Chandragiri of Gajapati district in Odisha. Though the COVID-19 pandemic is not an immediate concern in this far-flung area of Odisha, hunger and poverty remains an issue in many settlements in and around Chandragiri.



The KIIT and KISS family have provided basic essentials and grocery for at least a month to the Tibetan families settled in Chandragiri and to the monks of Padmasambhava Mahavihara Monastery in Jirang, the largest Buddhist monastery in Eastern India. Besides food, a kit containing essential items like sanitizers, hand wash, sanitary napkins and masks were also provided by KIIT and KISS, facilitated under the visionary leadership of Prof. Achyuta Samanta, Lok Sabha MP from Kandhamal and Founder of KIIT & KISS.



Feminine hygiene products were also handed over to District Administration for distribution among women and girls in Ganjam. Notably, KIIT and KISS have provided grocery for two old age homes in Chandragiri and have pledged to adopt both and take care of all finances henceforth. "This crisis is not going to pass soon; it will take its time. Each one of us is inextricably connected to each other. We can overcome these difficult and unimaginable days only by being together. The real war with Corona is not now, it is also the aftermath", said Dr. Samanta, while informing that their contact with the monastery dates back to a decade. Guru Gyetrul Jigme Rinpoche, the head Lama of the Monastery has congratulated

Dr. Samanta for his thoughtful leadership and compassion.



## KISS Foundation continued providing free cooked food to needy people in 15 districts of Odisha

KISS Foundation provided cooked food to needy people in fifteen districts of Odisha during second wave of pandemic. After the lockdown was extended till May 31, KIIT and KISS have started the drive to provide free food at 21 places including 18 places in 15 districts and 3 places in Bhubaneswar. KIIT and KISS have decided to run the free food drive till May 31. KIIT and KISS Founder Dr Achyuta Samanta personally monitored the drive. Odisha government has extended lockdown till May 31 in the wake of severity of the Covid pandemic.

During this period cooked food (lunch) was provided by KIIT and KISS to poor and helpless people in 15 districts including Koraput, Rayagada, Malkangiri, Nabarangpur, Kalahandi, Balangir, Sambalpur, Sonepur, Sundergarh, Keonjhar, Mayurbhanj, Kandhamal, Boudh, Ganjam and Gajapati. In Bhubaneswar, KIIT and KISS provided cooked food for Buddhanagar Leprosy colony, Mancheswar Jagannath Leprosy colony, Keshari Nagar Swapna Trust and Blind Association in Ward No 41 for both, lunch and dinner.

## Free Education in KIIT For Children of Covid Deceased in Odisha

The Covid-19 pandemic has infected millions and caused much panic across the globe, including India and Odisha with increasing corona virus infections and perils of loss of life looming large. KIIT has reached out to the distressed people at the time of natural calamities in the state. It has become the pride of Odisha as it has always stood by the people of the state at the time of their need. The Covid-19 pandemic has disrupted and devastated normal life and livelihoods of the people of Odisha. Now KIIT Deemed to be University has extended a helping hand to the families of the Covid deceased. The Founder of KIIT & KISS, Dr. Achyuta Samanta, as a humanitarian gesture has declared to provide technical and professional education absolutely free of cost to the children of the Covid deceased. Sons and daughters of the Covid deceased, who are interested, can apply to different technical and professional courses of KIIT-DU, including ITI and Diploma Engineering, as per their eligibility for admission. This facility will be available for two academic years, 2020-21 and 2021-22 only, informed KIIT authorities. Preference will be given to the children of Covid deceased from BPL, SC, ST and SCBC categories. The move will provide relief to the people of Odisha who have been made helpless by the pandemic. KIIT is the only university in India and abroad to extend such humanitarian gesture to the families of the Covid deceased.



## Reaching the unreachable



## Financial support to Orphaned children of Langhar Village

The four siblings of Langhar Village under Srikrushnasaranpur Gram Panchayat of Khallikote PS District Ganjam were pushed to the dark plight of poverty as the head of the family succumbed to HIV AIDS few years. Amidst all the adversities and economic hardship, she never let the siblings feel the absence of their father. The surviving mother who was also infected with HIV was struggling hard for the basic wherewithal for the siblings scouting for daily wage earner in and around their native village. Although the deadly HIV was gradually crippling her, she was undeterred to face the challenges being



being careful to maintain the daily chores for the siblings and strived hard to make both ends meet with casual employment opportunities at nearby villages including opportunities at Capital City Bhubaneswar. In one such event while undertaking journey by Auto rickshaw, she met



with a fatal road accident and succumbed to death leaving the siblings orphaned. With the social media and TV channels aired the grueling and heart wrenching story of the orphaned girls, it drew the attention of the Founder of KIIT and KISS Dr Achyuta Samanta. KISS Foundation swung to action and reached out to the orphaned girls and offered financial support of Rs 20000/- instantly to rescue the orphaned girls and offered Rs 10000/- per month for their food, shelter, upbringing and nourishment. The Foundation also promised to provide education to Mamata Das and her sisters with admission at nearest KISS institution as per their eligibility absolutely free with free accommodation and boarding and other amenities compatible for a wholesome and all-round development of these deprived girl children. The guardians, neighbours, residents of the village and well-wishers of the orphaned girls of Langhar village expressed their gratitude for the deep sense of compassion and humanity shown by the Founder of KISS, Dr Achyuta Samanta to the orphaned children at this challenging times. The Local MLA of Khalikote Constituency also conveyed heartfelt thanks to the Founder of KISS Foundation Dr Achyuta Samanta for his timely action for affording financial support to the needy orphaned girls at this desperate moment which would support in their survival and thriving for a glorious future.

### Support to families of road accident in Ganjam

KISS Foundation has come to the rescue of the families of some road accident victims of Ganjam district. The migrant laborers returning back to Surat lost their lives in a serious road accident. The families of the deceased were in dire distress. On learning about their plight, on the advice of Prof. Samanta, KISS Foundation has come forward in arranging education at any of the KISS centres for the children of these accident victims. It was also decided to provide jobs at KIIT & KISS to any one eligible family member of the victims.

### Financial Help to three orphaned children of Sundarpur Village

In another development, KISS Foundation has extended support to three orphaned children i.e., Dipti Rani Mahakud and her two sisters of Sundarpur

village under Chhatrapur Block of Ganjam district. The children had lost their father some years back & later their mother expired, who was the only earning member of their family. After knowing the plight of three orphaned children, on the advice of Prof. Samanta, KISS Foundation extended its supporting hand by offering a monthly allowance of Rs. Five thousand only & education facility at KISS to the children.



### Sponsorship to pursue career in Medicine



A poor and talented student Jyotiranjan Das of Haldipada village near Baishinga in Mayurbhanj District cracked Medical Entrance and got enrolled in MKCG Medical College at Brahmapur in 2018-19 academic year. In fact, Jyotiranjan had passed Matriculation and Plus 2 exams securing 80 percent of the total marks, and had cleared the Medical Entrance exam in his

maiden attempt. However, after the end of first year, he could not proceed further following poor financials. His father a tailor by occupation, was struggling to make both ends meet, was unable to provide support. Consequently, Jyotiranjan failed to carry on his MBBS study. On learning about his precarious financial condition, KISS Foundation promised to provide him with financial support in terms of Rs.10000/- scholarship per month till completion of his MBBS Course. Other kind of support would also be made available as per need. The meritorious student's career would have ended abruptly without the timely support of KISS Foundation.

### Donation of Wheelchair to Differently-abled Girl-Subhadra

Subhadra Gumjira, a resident of Teranti village under Sukuli block in Mayurbhanj district is differently abled from childhood. Subhadra's father died some years ago, while her mother strives to make both ends meet working as a daily wage labourer.





Subhadra has an intense desire to pursue her study career, and is being compelled to rely on others to attend school. On getting to know about Subhadra's plight Dr. Samanta extended his helping hand to Subhadra. He arranged financial assistance to Subhadra on behalf of KISS Foundation by providing two thousand rupees as a monthly allowance. Besides, Subhadra was assured free education as long as she would like to pursue her study. A wheel chair was donated to Subhadra. The local district authority was requested to provide them with a house as per Government norms. Dry food, fruits & groceries were also offered to the family. Subhadra's brother would also pursue his study in KISS.

### KISS Foundation extends helping hand to 6 orphan siblings of Gajapati district

KISS Foundation has taken the responsibility for six helpless orphan siblings Sarojini Dalabehera and her sisters of Gajapati district of Odisha. Urbang Dalabehera and his wife Sujani of Khari Sahi village in Gajapati district died last year suffering from fever. Following their



death, their six children became orphans. However, the elder sisters Surajani and Urbhani started working as daily laborers to look after the family. KISS Foundation has suggested the orphans to attend school & immediately provided them with Rs. 5000/- for their maintenance. Free education was assured to them at KISS. The Foundation would look after them & provide Rs. 5000/- monthly allowance. Surajini, Urbhani and the siblings have conveyed their gratitude.

### Support to Migrants in Bolangir



Sanatan Bhoi (13), Krishna Bhoi (10) & Kedar Bhoi (7) are the children of Late Premsila Bhoi of village Ranipur, GP - Jharial, Block - Bangomunda, district - Bolangir. They belong to the ST Community of Kandha. The father of the family, Late Dibakar Bhoi, a migrant

labourer had passed away three years back. Now after the death of the mother, who succumbed to a disease, the three children have become

helpless & orphaned. They were living in a dilapidated building. Though the neighbours provided some support in the form of rations, it was not enough. Now the children have taken shelter in their relative grandfather's house, & a big question mark hangs over the fate of the children.
